

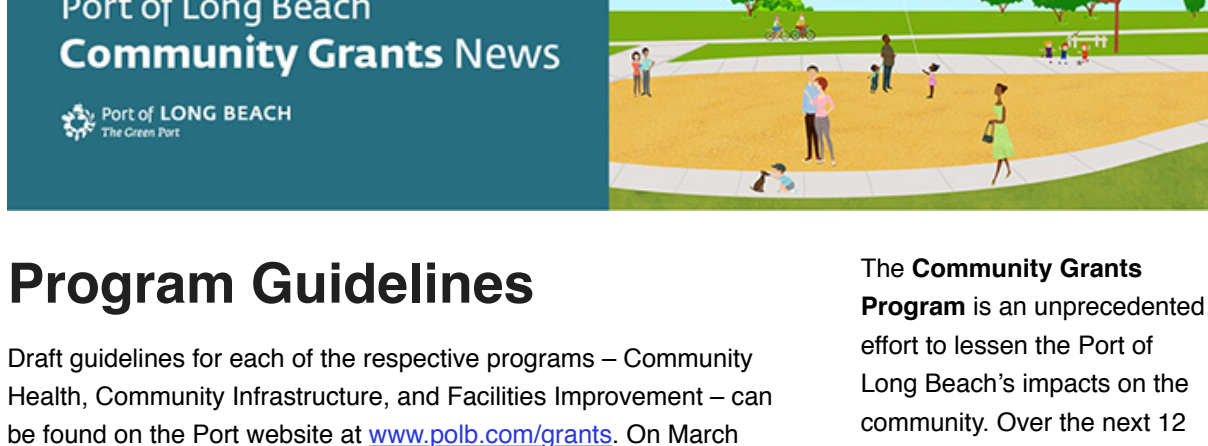

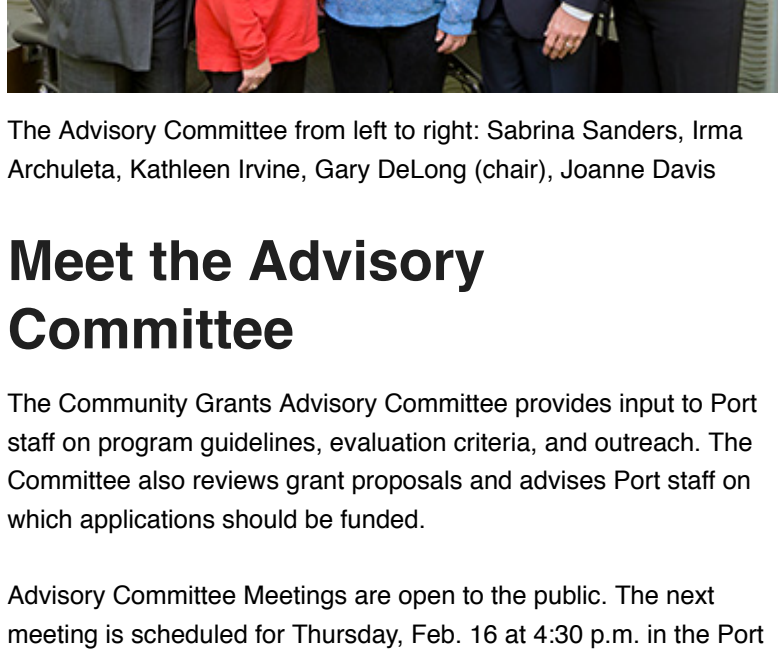


Program Guidelines

Draft guidelines for each of the respective programs – Community Health, Community Infrastructure, and Facilities Improvement – can be found on the Port website at www.polb.com/grants. On March 13th, the guidelines will be brought to the Board of Harbor Commissioners for formal approval. Development of program guidelines involves close collaboration with subject experts, the mayor-appointed Community Grant Program Advisory Committee (Advisory Committee), and Port staff.

The **Community Grants Program** is an unprecedented effort to lessen the Port of Long Beach's impacts on the community. Over the next 12 to 15 years, we plan to invest \$46.4 million toward community-based projects that reduce our impacts on air quality, traffic, noise, and water quality.

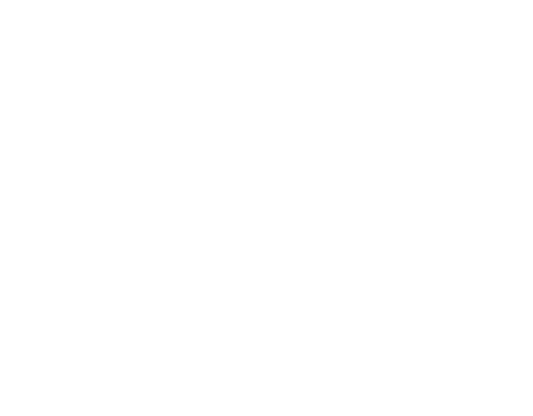
Sabrina Sanders

Project Highlight: Friends of Colorado Lagoon 'Summer Science Shack Event'

The Friends of Colorado Lagoon provided the Summer Science Shack event at Colorado Lagoon, thanks to the Port's previous Mitigation Grant Program. With a \$1,500 grant, we provided an all-day marine science education and exploration program for the community along the shoreline of the Lagoon. This family-oriented event included a beach cleanup, snorkel training and tours in the Lagoon, marine life collection and educational touch tank building with FOCL naturalists, a marine life arts and crafts corner and land tours of the upcoming (now underway) major restoration phase at Colorado Lagoon.



More than 300 community members along with City officials, non-profit organization leaders, environmental agency representatives and local press attended this event.

Due to the popularity of this program and the high volume of summer visitors each year at the Colorado Lagoon who may not have other coastal access opportunities, we see this program as critical to promoting coastal conservation and awareness and providing a safe, easily accessible recreation area for families from our more urban communities. We would like to extend this program to span the duration of all weekends during summer months to support the thousands of local residents visiting Colorado Lagoon.
